2) photographed or scanned receipt of the registration fee (filename must contain the name of the participant (*example of the filename: Kvytanziya_Ivanov I.I.*)).

3) to fill in the registration form on www.bef.in.ua.

The official languages of the scientific conference are Ukrainian, Russian and English.

The form of participation in scientific conference: extramural.

The external participation in conference means that the collections of articles will be send to the participants of the event to the address specified in the application in seven days after the conference.

After the conference you will receive the collection of abstracts in A5 format with a glossy cover and indexes UDC, BBK and ISBN by mail.

After the conference a collection of your articles will sent to academic and university libraries and institutions. Also you can get **a certificate confirming your participation in the conference** (you must pre-pay 30 UAH for each certificate).

Requirements for abstracts:

Size of text - 5 pages (if the size is bigger, the registration fee must be accounted by 30 UAH per each page) A-4 format in a text editor Microsoft Word for Windows as a file with the extension *.doc, *.docx; font - Times New Roman, size of font -14, 1.5 line spacing, retreat - 10 mm, margins - 20 mm.

The sequence of designing of articles: the direction of the conference relevant to the article, name of the author (maximum of two person) (font- bold, italic), position, university, place of employment, a city where it is located, the state (font- italic) title (capital letters, font- bold) text.
